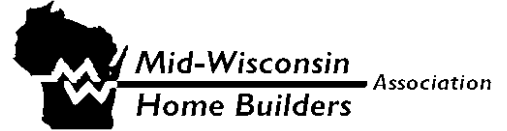


Contract for Exhibit Space – MWHBA Home Products & Remodeling Show

This agreement is made between the Exhibitor named and the Mid-Wisconsin Home Builders Association, hereafter referred to as MWHBA, Exhibitor agrees to rent exhibit space, subject to the terms defined in this Agreement, the terms in the Home Product & Remodeling Show Rules and Regulations and in the Glacier Canyon Convention Center at the Wilderness, which are made part of this Agreement by references, the terms of setup and takedown and any other regulations as will be noticed prior to the Home Products & Remodeling Show, MWHBA agrees that if this contract is accepted by MWHBA, space will be made available as described on the official floor plan, to be used for display purposes only at the MWHBA Home Products & Remodeling Show to be held February 19, 20 and 21, 2010.

Service Orders: Exhibitor acknowledges that Exhibitor must arrange for service orders (materials other than one back curtain per booth.)

Down Payment: Enclosed is check # _____ for \$ _____ as (check one) ___ down payment ___ Full payment for ___ (#) booth(s).

Final Payment: Final payment is **due October 15th. (Note: Full payment must accompany contract if signed after October 15th.)**

Limitations: In addition to the requirements of this Agreement and the Rules and Regulations of the Home Products Show, Exhibitor shall be bound by and shall comply with all governmental laws, rules and regulations applicable to Exhibitor and the Home Products Show, and all rules adopted by the Glacier Canyon Convention Center at the Wilderness, as they may be amended from time to time.

MWHBA maintains the right, without notice, to waive or extend any deadline or time limit, and to waive any other right which it may have under this Agreement. Any waiver of, or failure to enforce, any right of the MWHBA, under this Agreement in any instance shall not waive or affect the right of the MWHBA to enforce that right in other instances. This Agreement shall be governed by the laws of Wisconsin. If any provision of this Agreement shall be found to be invalid by any court or proper jurisdiction, the remainder of this Agreement shall remain in full force and effect as if that provision had not been included in this Agreement.

This Agreement shall not be final until signed by both the Exhibitor and MWHBA, but when so signed will constitute a binding contract between parties. Exhibitor should not assume that a request for exhibit space has been accepted until Exhibitor has received a signed copy of this contract from MWHBA with assigned booth numbers specified.

Cancellations: Refunds for cancellation of booth space will only be available for Exhibitors to whom MWHBA has sent an executed contract on or before November 30, provided that the cancellation request signed by the authorized representative is received in writing by MWHBA not later than November 30. Contracts executed after November 30 shall not be eligible for a refund.

57 **Expenses and Attorney's Fees:** In case of default, whether abated or not, Exhibitor agrees to pay all costs incurred by MWHBA in
58 enforcing this Agreement, before and after the judgment, including, to the extent not prohibited by law, reasonable attorney's fees.
